I. AGENDA MODIFICATIONS

II. CITIZEN COMMENTS

There were no citizen comments.

III. PRESENTATION / INFORMATION ITEMS

Status Update Presentation of the Northeast Connector: Bannerman Road

Northeast Connector Consultant Project Manager, William Waldroff provided an update presentation on the Northeast Connector project. Mr. Waldroff provided an overview of the segmentation of the Bannerman Road road-widening component of the Northeast Connector, and provided the CAC graphics showing the typical sections of each segment. Mr. Waldroff provided the current status of the project and informed the CAC that the Northeast Connector also included the Orchard Pond Greenway, Bull Headley Sidewalk, Tekesta Sidewalk, and Meridian Road Greenway components. Mr. Waldroff indicated that the project design will be at 60% completed in Fall 2023 and 90% plans will be completed by Spring 2024.

CAC member, Fred Varn, asked how will the road widening affect Tekesta Park and Mr. Waldroff replied that although there will be no path built into the park, there will be approximately 16 pull-in, parking spots including disabled parking spots added in close proximity to the sidewalk, to serve as a trailhead.

Committee member, Hollie Meyers, asked whether there were any plans to bring new residential developments in the project area onto City of Tallahassee sewer systems, Mr. Waldroff indicated that was outside the scope of the Northeast Connector project.

Committee member Mary Glowacki asked about right-of-way acquisition, and the use of existing right-of-way, Mr. Waldroff indicated that they have to wait until the plans are at 60% completion, because that means that the designs are pretty much done, so after 60% completion, the right-of-way needs are set. In response to questions regarding wetland impacts from CAC member Peter Okonkwo, Mr. Waldroff said that they do have some wetlands and wetland impacts in the project & currently have not secured the permits from the city and county yet, but have been in communication with the City and County on the impacts they're currently facing.

Blueprint Director, Autumn Calder then talked about the stormwater standards that Blueprint has to meet for Northeast Connector project area, and how they're making every effort to minimize residential and environmental impacts. She said that the project team is getting close on the precise location of the stormwater ponds, and highlighted there were 111 parcels along the corridor.

CAC Chair, Rod McQueen brought up the need to ensure that the landscape selection provides good view lines, and that there is adequate lighting for our school bus stops along the project corridor, to ensure the safety of Leon County Schools students. Mr. Waldroff agreed and gave specific examples of how the project is addressing those concerns.

OEV Status Report

Office of Economic Vitality Deputy Director, MWSBE Darryl Jones provided a status update on OEV activities. As part of this update, he highlighted the Amazon facility, Non-Competitive Projects, and Workforce Engagement information.

Q2 2023 Blueprint Infrastructure Project Status Report

Blueprint Principal Planner, Mike Alfano provided brief information on the Q2 Infrastructure Project Status Report document.

2. Status Update Presentation on the FY 2023 Annual Report

Blueprint Principal Planner, Mike Alfano gave a presentation on the FY 2023 Annual Report, including Blueprint's impacts such as investments made by Blueprint in FY 2023 and the metrics of improvements that projects funded will provide, projects under or going to construction in late 2023 and in 2024, and on the awards won by Blueprint in FY 2023. He also highlighted information within the FY 2023 Annual Report for OEV. Blueprint will furnish copies of the Annual Report to the CAC, upon publication.

As there was no quorum, no vote was taken.

VI. PUBLIC HEARING 5:00 PM

3. <u>First Public Hearing on the Proposed Fiscal Year 2024 Operating Budget and Fiscal Year 2024 – 2028 Five-Year Capital Improvement Program Budget for the Blueprint Intergovernmental Agency</u>

Blueprint Director, Autumn Calder, provided an overview of the FY 2024 Budget development process and indicated that the FY 2024 budget has to be adopted before the beginning of the 2024 fiscal year which starts on October 1, 2023.

Blueprint Finance Officer, Tres Long then went over the revenue estimate updates and five-year infrastructure revenue sources. He indicated that revenues have gone up and are projected to continue to rise.

Blueprint Director Calder then presented on the proposed Blueprint Infrastructure FY 2024 Operating Budget and Capital Improvement Plan, as well as highlighting the leveraging successes of the Blueprint Program and impacts of the five-year work program.

Office of Economic Vitality- MWSBE Deputy Director, Darryl Jones then provided an overview of OEV's 5-year revenue sources and uses, as well as the proposed FY 2024 OEV Operating Budget and Capital Improvement Plan.

Committee members, Fred Varn and Mary Glowacki asked questions regarding Blueprint's use of bonds, loans, interest rates, and debt service, and how that factored into the budget. Mr. Long provided an overview of the use of the sales tax to pay off debt service, and how those payments are included in the proposed budgets. He said interest rates for the upcoming planned bonds are not known yet, because they're competitive and have to be negotiated. For the loans, he said Blueprint is currently in the application approval process through Florida Department of Transportation (FDOT). As it relates to the bond rates, Mr. Long said that it should be by approximately mid-Spring when Blueprint goes to market. Director Calder also provided that three previous bond issuances had been issued to Blueprint and paid back. Mr. Long highlighted how focus/direction from the IA Board has been to implement as many projects as possible, in the near term. He also provided that all Blueprint projects are fully funded, and assured CAC members that there will be sufficient revenue to cover the debt service.

SUPPLEMENTAL INFORMATION:

Rod McQueen served as the 2023 Chairperson, and Ashley Leggett served as the 2023 Vice-Chair. Ashley Leggett will ascend to Chair effective January 1, 2024. See below for Section 1.6 of the CAC Bylaws relating to elections. If a quorum is not obtained, the election will occur at the first meeting of 2024.

- 1.6 CAC OFFICERS, ELECTIONS, AND DUTIES
- (1) The CAC's officers will consist of a Chairperson and Vice-Chairperson elected from its membership.
- (2) The Chairperson and Vice-Chairperson shall be elected by a majority of the votes of CAC members present.
- (3) The Chairperson shall serve as Chair for a period of one year effective January 1 of each year.
- (4) At the last meeting of the CAC each year, a new Vice-Chairperson shall be elected for a term of two years, the first year to serve as the Vice-Chairperson and the second year as the Chairperson. (This will become effective with the election conducted in late 2010.) Nominations for the Vice-Chairperson shall be made at the meeting. The current Vice-Chairperson can decline becoming the Chairperson if so desired.
- (5) The CAC Chairperson shall preside at all meetings. In the event of his/her absence, or at his/her direction, the Vice-Chairperson shall assume the powers of the Chairperson. In the event that neither the Chairperson nor Vice-Chairperson can preside at the meeting, the Committee members present shall elect one of its members to serve as temporary Chairperson for the meeting.
- (6) In the event that either the Chairperson or the Vice-Chairperson position becomes vacant, a replacement shall be elected at the next scheduled CAC meeting for immediate assumption of duties and shall hold the position for the remainder of the calendar year.
- (7) The Chair shall appoint Chairs of all committees, standing or special.
- (8) It is the Chair's responsibility to ensure compliance with the Bylaws. The Chair will notify members of removal from the CAC for non-compliance. Specific questions regarding conflict of interest will be addressed by the attorney for the Intergovernmental Agency.
- (9) The Chair shall immediately, upon receipt of a resignation or when advised of a vacancy, notify the Chair of the Intergovernmental Agency to begin the appointment process.

SUPPLEMENTAL INFORMATION:

Blueprint CAC membership positions and terms are established in the Second Amended and Restated Interlocal Agreement and further defined in the CAC Bylaws. CAC members may serve two consecutive three-year terms. However, in the case of the fulfillment of partial terms, all members shall still be eligible to serve two full terms in addition to fulfillment of partial terms. The current CAC roster is included as Attachment #1.

The Second Amended and Restated Interlocal Agreement requires 14 CAC members serving three-year staggered terms, which shall be selected as follows:

- 1. Four members selected by the IA Board from a list of applicants that shall include at least one from each of the following categories:
 - a. At least one financial expert with bonding experience
 - b. At least one planner
 - c. At least one natural scientist/biologist
 - d. One member serving in an at-large position
- 2. Three members shall be selected by the IA Board including one member from the civil rights community, one member from the elderly community and one member from the disability community.
- 3. The remaining seven members shall be selected as follows:
 - a. Board Member of the Greater Tallahassee Chamber of Commerce
 - b. Board Member of the Capital City Chamber of Commerce
 - c. Board Member of the Big Bend Minority Chamber of Commerce
 - d. Chairperson of the Planning Commission or Designee thereof
 - e. Representative from the Council of Neighborhood Associations
 - f. Representative from the Big Bend Environmental Forum
 - g. Representative from the Network of Entrepreneurs and Business Advocates

Per the CAC Bylaws, CAC memberships are attained through the appointment of members by the IA Board, with the exception of the member described in section (1)3.(d), which shall either be the Chairperson of the Planning Commission or a Designee selected by the Chairperson of the Planning Commission. Members are either nominated by organizations that hold a seat on the CAC or through direct application to the Agency. All prospective committee members, excepting the Planning Commission designee, are required to submit an application to the Agency, which is then reviewed by staff to ensure the application is consistent with the requirements of the CAC bylaws for that specific CAC seat. Applications are then provided to the CAC at a publicly noticed meeting for consideration and recommendation to the IA Board. Finally, CAC applications are submitted to the IA Board as an agenda item, including the recommendation from the CAC, for their consideration and appointment.

REAPPOINTMENTS

Chris Daniels, currently holding the at-large CAC seat, and Mary Glowacki, currently holding the planning expert seat, have requested to serve second, three-year terms on the Blueprint Citizens Advisory Committee. Blueprint is seeking a CAC recommendation that the IA Board reappoint these members to the CAC.

APPOINTMENTS

Two positions on the Blueprint CAC have their members' terms expiring and are ineligible for reappointment. Peter Okonkwo, who filled the role of the Capital City Chamber of Commerce representative and Elva Peppers, who filled the role as the Natural Scientist/Biologist, have each completed two consecutive three-year terms.

Consistent with previous practices, the Capital City Chamber of Commerce provided a nominee to represent their organization on the CAC and, as such, Blueprint is seeking a CAC recommendation that the IA Board appoint Byron Greene to this seat. Mr. Greene's application materials are included at Attachment #2.

Blueprint advertised the Natural Scientist/Biologist position on the Blueprint website from August 18 to September 29, 2023 and received three applications. Blueprint has reviewed the applicants' materials and determined that all three meet the criteria for the position. The eligible applicants are (in alphabetical order): Maria Therese Brown, Chuck Goodheart, Christina Omran. The applicants' application materials are included at Attachments #3-5. Blueprint is seeking CAC recommendation for one or more applicants for IA Board consideration. The IA Board will consider the applications and make the final decision on the appointment at their November 7, 2023 meeting.
