4. Presentation on the Bike Route System Implementation Process and Review of the Downtown-University Protected Bike Lane Project

Autumn Calder introduced the Bike Route System item. Mike Alfano provided a brief presentation of the project implementation process including the annual work program and facilities gap analysis with the Planning Department. The first project for IA Board consideration would be the review of the Downtown-University Protected Bike Lane Project (BPL). A 2.9-mile project that would create permanent protected bike lanes and connect downtown with nearly 4,000 beds and 250,000 square foot of commercial and retail space. Blueprint anticipated design to be completed late in 2021 with construction coordinated with the City of Tallahassee roadwork planned for 2021-2022.

Autumn Calder stated that the bike route annual work plan would piggyback on the existing roadwork projects and work plans of the City and County in an effort to maximize Blueprint funds and minimize construction disruptions. Steve Shafer suggested that Blueprint also coordinate with Neighborhood and Community Services, particularly in the southside neighborhoods. Many of the recent conversations for improvements included bicycle and pedestrian options.
